## **KEY MESSAGES OF ROUNDTABLE DISCUSSION**

- The system of care for people with mental illness must be reformed in Slovakia.
- Psychiatry is an integral part of general medicine and the reform of health care must include the reform of mental health care.
- Mental health system and social care system should be interconnected.
- The Reform of the system of mental health care should be a continuous process based on a specific long-term plan executed in successive steps, emphasizing prevention and psychosocial rehabilitation.
- Psychiatric care requires the participation of psychiatrists, as well as psychologists, nurses, patients and family caregivers, social workers, peer consultants and other persons active in promotion of public mental health.
- The goal of psychiatric care is the integration of patient in their families and their communities and in the work space.
- The direct and indirect costs of mental illnesses and of care for people with them should be recognized and provided.
- The principles of the reform must be reflected in general education and in the education of professionals involved in the care for mental health.
- Psychotherapeutic and communication skills should be an integral part of the teaching and training of mental health professionals.
